Registration entitlements

Registration fee includes access to all conference sessions, all conference materials, all conference catering including lunches, morning/ afternoon teas, the conference networking session/cocktails on Friday 27 May and the conference dinner on Saturday 28 May. Neither LAWASIA nor the *4th LAWASIA Children & Law Conference* will be held liable for any costs (other than as shown in registration entitlements) under any circumstances.

Social function tickets for accompanying persons

Should you wish to bring an accompanying person/s to the social functions, tickets may be purchased via the registration form. Please note that it may not be possible to purchase extra tickets on site.

Accommodation bookings

Delegates should make their own accommodation reservations directly with hotels. The LAWASIA secretariat regrets it is unable to accept hotel reservations.

A limited number of rooms have been held at the conference hotel, the Tara Angkor Hotel, at the rates/inclusions shown on the accommodation booking form. Please note that the Tara Angkor Hotel is unable to guarantee availability of rooms after 27 April. Delegates are advised to make their reservations as early as possible before that date.

OPTIONAL POST-CONFERENCE TOUR (not included in registration fee)

Return to the town centre for a buffet style dinner at the Tonle Mekong restaurant to sample many Cambodian and South East Asian dishes whilst traditional Cambodian dances including the classic Apsara Dance
